[00:02:20] Hon. Junet: Mr. Speaker, I'm holding brief for the Minority Leader, Mr. Speaker, who is away on an official business for the party. Mr. Speaker, the last time we discussed amendments to a bill on an election, like one we are about to discuss, Mr. Speaker, in the 11th parliament, Mr. Speaker, was a very important battle, Mr. Speaker.

I remember we formed a bipartisan party, Mr. Speaker, where even I served Mr. Speaker. The issue was so important, Mr. Speaker, not the way it's being handled casually like this, Mr. Speaker, that because you have numbers, you can just bring amendments to the house, Mr. Speaker, and we expect them to go through Mr. Speaker.

This is a very important matters to this country, Mr. Speaker. This is changing the rules of the game in the middle of the game, Mr. Speaker, and I'm sure as if I heard Jubilee very clear, they said the president won the elections Mr. Speaker. If he has won, we don't need to change the rules. Mr. Speaker.
